Workshop - Hemlock Woolly Adelgid and Spotted Lanternfly

Hemlock Woolly Adelgid (HWA) is an invasive, aphid-like insect that severely damages Eastern and Carolina hemlocks and has spread significantly throughout New York State. Workshop topics include information on the NYS Hemlock Initiative, hemlock ecology, basic HWA biology, HWA natural and chemical controls with a special emphasis on new biocontrol efforts at Cornell University. Spotted Lanternfly is an exotic, invasive insect that was first detected in Pennsylvania in September 2014. As populations continue to spread, it is likely to have a major impact on forests and agriculture in New York. The lengthy host plant list includes apples, cherries, grapes, peaches, hops, pine, oak, walnut and poplar. The presentation will cover Spotted Lanternfly identification, biology, distribution, damage and potential controls.

Keynote Speaker:

Laura E. Ayers, Esq.

New York Attorney Laura E. Ayers focuses her law practice on real property. As a business developer in her home state of New York, Ms. Brockelbank provides community and urban forestry solutions focusing on outreach, planting, and risk management. Ms. Brockelbank is an International Society of Arboriculture (ISA) Certified Arborist and Municipal Specialist (NY-5326AM) and is also Tree Risk Assessment Qualified (TRAQ) through ISA. Ms. Brockelbank is also a graduate of the Municipal Forestry Institute (MFI). The major forest health concerns at present relate to the loss of biological diversity, invasive species impacts, climate change, and forest sustainability. Garrett Koplun

Garrett Koplun is a private lands forester for NYSDEC in Region 8, Avon. His primary duties include: ReLeaf committee planning; working directly with private forestland owners on stewardship planning; layout of forestry practices; administering forestry cost-share grants; administering the NYS Forest Tax Law 480a; inspection of urban forestry grant projects; and various educational outreach activities. Garrett is an ISA Certified Arborist (NY-5605A) and member of the USFS Northeast Area Urban Forest Strike Team. Garrett has helped coordinate and participated in three large volunteer tree plantings through the NYSDEC's Trees 4 Tributaries (T4T) program. Each of those plantings had a focus on replacement of riparian forest canopies where there was a heavy component of green ash. The T4T planting at Oatka Creek Park was amongst those plantings. Garrett graduated from SUNY Ranger School in 2004 with an A.S. in Forest Technology and SUNY College of Environmental Science & Forestry in 2006 with a B.S. in Forest Resource Management.

Chris Peiffer has a Bachelor of Science, Urban Forestry Degree from Pennsylvania State University and specializes in urban forest planning, management, development, and innovation. He is experienced in tree inventory and assessment data collection, synthesis, and analysis and urban forest management plan writing. This experience includes regional canopy action plans and strategies, urban forest management / master plans, strategic planting plans, analysis and reporting of statewide tree inventories, strategic planting plans, and Urban Tree Canopy (UTC) reports. He has written or contributed to each management plan conducted by Plan-It Geo and recently, Chris managed and completed a countywide 168,000 street tree inventory staffed with 6 Tree Inventory Technicians. Mark is currently the director of the New York State Hemlock Initiative and the Hemlock Woolly Adelgid Biocontrol Research Lab at Cornell.
